## **IMPORTANT MESSAGE FROM BETH BRAINERD REGARDING YEAR END AWARDS FOR 2020:**

### **2020 Covid-19 Amended Year End Awards**

Due to Covid-19 concerns and restrictions we will not be having our annual banquet at the Senator Inn in January. We do however, want to make our awards season as rewarding as possible.

### **Barn/Club Options:**

Our barn is going to collect our students awards and do our own little barn family, socially distanced awards ceremony so with that in mind we are offering the following options;

I will box all the awards, including trophies and larger awards as necessary, for each barn group or club and we can arrange for the box to be picked up or delivered.

There will be (and is included in this emailing) a revised Year Ends Award Report form that includes your barn or group where your award(s) can be sent. Please discuss and include a contact person for the awards for your group.

If you are 'on your own' your awards can be included in a box going to your area or I can mail ribbons and final results but not trophies or larger awards.

Also, when you send in your results we would like a digital picture of you and your horse (if you are so inclined). The plan is to create a slide show we can share at our barn events and hopefully, on facebook. At the least I can include the pictures in the program which I will include with the awards that are sent out.

Our plan is to have delivered all the awards by the last Sunday in January and then send out the digital program to the barn groups and clubs on the 31 st of January.

### **A reminder that the requirements for this years awards have been modified and are as follows:**

**Intro through 2nd Level:** You will need at least 4 scores from two shows and two different judges.

**3rd Level and above:** You will need to submit at least 2 scores from 2 shows and 2 different judges.

Medal requirements have not changed. Specials Categories have also revised to match the above new requirements.

#### **Director Report**

*2020 Show season – Impact COVID-19 had a large impact as our region's show season did not even start until mid-July. The shows that did run had constraints with stabling etc. VERY tough year. 2021 Show Season – Discussion lead to believe the region will have a more 'normal' number of shows. It is fairly certain that COVID protocol will remain in effect which can again limited the number of stalls available etc...Fingers Cross!!!*

*US Dressage Finals – Debra explained that USDF could not take the chance of a Covid positive case at the National Horse Show which is the week before at the KY Horse Park and park shutdown. Our riders travel too far and too expensive to take that chance. NHS also said they were not doing social distancing stalls in the heated barns, ie they would use every stall.*

*Are there any issues from our region to bring to the Executive Board – None at this time.*

*Financial Report – Sally reported the only income was \$155 which came from NEDA members donating to Region 8 on their membership application, and small amount of interest. No other activities for the year.*

#### **Reports**

*GMO Nominations – Kate reports GMO proxies are 'bysmal'. She thinks once the agenda for the virtual convention comes out it will be easier to push them to turn in these proxies. Debra said she would do her thing and contact the ones who are not answering when Kate needs the help!*

*NAYC – Bobbi was absent but Debra reported that Bobbi was the new Region 8 JrYR Coordinator. She also informed that April 10-11 Weatogue would hold JrYR clinic with George Williams. Bobbi will be contacting the Jr/YR of the region to fire them up for the clinic/*

***Raising Funds - Kate, Tabled***

***Competition Management – Anita reported that the committee had not been very active since there was not much shows happening or issue that could be solved.***

***Regional Championships – Debra reported that the 2020 Regional Championships were awesome***

***and that HITS could not of been friendlier and helpful. They had 361 entries with 350 verified Regional championship rides. All in all great time for all.***

***Beth reported for 2021 Regional Championships were a go at Saugerties with Sue McKeown as manager and Debra Reinhardt as Secretary.***

***GMO – Cindi reported 160 people participated in the new Recognition of Schooling show program, but Region 8 only had 8 participants.***

***Convention 2020 – Virtual with zoom calls. The agenda should be out shortly. Only one Regional Meeting during the convention for one hour and 15mins done after the committee meetings. At this point we are not going to schedule another meeting before the convention but if we don't finish business in that time allotted, we will schedule one later.***

***Normally the Region dresses in a color for the Board of Governors, but with this convention being virtual that will not have the impact. BUT Darian will create a background that we all can use with the Region 8 logo. She will send us all instructions on how to do it!***

***New Business – Education Programs? Will they be allowed. Debra reported that Kathie Robertson and she have been working with USEF. On 10/6, USEF COVID action plan allowed educational programs.***

***Spring Meeting date – April time frame but exactly date will be decided at convention.***

***Adjourn at 8:48pm with thank you to Lendon for allowing us to use her zoom account.***

**\*ATTENTION ALL 2020 COMPETITORS\***

EMDA would like to remind all members of the changes to year-end award score reporting:

In order to qualify for EMDA year-end awards, members need to submit their top 4 scores from at least 2 judges at any EMDA show for Intro through First Level. Members need to submit their top two scores from at least two judges at any EMDA show for 2nd Level and higher. Competitors will no longer be required to submit all of their scores earned, only their top scores. This will hopefully encourage our members to attend more shows without fear of having a negative effect on their median score at the end of the season.

Our Annual Awards Banquet will be held on Sunday, February 7th at 10:00 AM at Horse Gait Stables in Dixmont. Members are encouraged to attend and bring potluck style brunch items. Hope to see you there!

## **EMDA ANNOUNCES NEW VOLUNTEER SCHOLARSHIPS FOR 2021!**

EMDA shows would not be possible without volunteers who donate their time and skills. We appreciate you and want to give back!

For the 2021 show season, EMDA will sponsor three separate \$100 scholarships that will be awarded to a volunteer from each of our three venues:

**Puckerbrush Farm**

**Infinity Farm**

**Peppergrass Farm**

Any person who volunteers at a show will have the opportunity to put their name in for the drawing at the end of the season. Each venue will randomly select a recipient at the 2021 awards banquet. The scholarships can be used for lessons or other expenses related to dressage education. The more you volunteer, the better your chances of winning!



### 2020 CMDA Year-End Awards Requirements

**\*\*These requirements are for the 2020 competition season ONLY\*\***

Rider must be a current CMDA member at the time scores are earned. Re-ride tests do NOT count toward year end awards. All scores must be earned at shows listed in the current year's TMSD Omnibus, and be given by a judge with a rating of "L" or higher ("r", "R", "s") Horse and Rider combinations are eligible for awards at two (2) consecutive levels. Should a combination qualify for three, the scores at the lowest level will be forfeit.

Year-end scores will be calculated by the level. If four (4) scores are submitted, the two middle scores will be averaged for a final score. If two (2) scores are submitted, the two scores are averaged for a final score. A final score of 55% or higher is required to qualify for an award.

To qualify for Grand Champion, or Reserve Grand Champion, one (1) of the scores submitted must be from the highest test of the level ridden.

Riders are required to submit a CMDA score report form, as well as a copy of the front of each test. Score submissions must be post marked by November 30th of the current competition year, for award consideration.

Introductory, Training, First and Second Levels: To qualify at each level, the horse & rider combination must submit four (4) scores earned at two (2) shows from two (2) different judges. One score must be from a CMDA show.

Third and Fourth Levels: To qualify at each level, the horse & rider combination must submit two (2) scores earned at two (2) different shows from two (2) different judges. One score must be from a CMDA show.

FEI (Prix St. Georges, Intermediate, Grand Prix): To qualify at each level, the horse & rider combination must submit two (2) scores earned at two (2) shows from two (2) different judges. One score must be from a CMDA show.

Western Dressage: To qualify at a level, the horse & rider combination must submit four (4) scores earned at two (2) different shows from two (2) different judges. One score must be from a CMDA show. Separation of divisions by junior/young rider, amateur, open and by levels will be at the discretion of the awards program manager.

Freestyles: To qualify, the horse & rider combination must submit two (2) scores earned at two (2) different shows from two (2) different judges. One score must be from a CMDA show.

Combined Test: To qualify, the horse & rider combination must submit two (2) scores earned at two (2) different shows from two (2) different judges. Due to only one CMDA show holding Combined Test classes, both scores can be from any show listed in the 2020 MDS Omnibus.

#### **WMDA Year End Awards Guidelines for Competition Year 2020:**

**All the awards will be ready to be picked up or delivered by January 31, 2021.**

#### **Modified Requirements:**

**Intro through 2nd Level: You will need at least 4 scores from two shows and two different judges.**

**3rd Level and above: You will need to submit at least 2 scores from 2 shows and 2 different judges.**

**Medal requirements have not changed.**

**Specials Categories have also revised to match the above new requirements.**
